# MINUTES BOARD OF LIBRARY COMMISSIONERS OF THE CITY OF GRAND RAPIDS

June 25, 2024 | 5:15 pm 111 Library St NE | Board Room

Anderson called the meeting to order at 5:15 pm.

#### 1. ROLL CALL

## 2. APPROVAL OF MINUTES OF THE SPECIAL AND REGULAR BOARD MEETINGS ON APRIL 30, 2024

MOTION: By Commissioner Woolsey, supported by Commissioner Kopec, that the Board of Library Commissioners of the City of Grand Rapids approve the minutes of the special and regular board meetings of April 30, 2024.

Kopec comments on Item 2 of the special meeting minutes. She clarifies that she asked if there was an annual step increase and also whether there were cost of living adjustments. Laplow says that she will edit this.

#### 3. BOARD COMMENTS

Anderson reads García Mazari's comments in her absence: García Mazari had the chance to attend the recent Author Talk with Emily St. John Mandel and says that it went smoothly. She adds that she visited the West Leonard Branch with her niece and nephew and they all had a great time. She also attended the new Creston Farmers Market and noted seeing many GRPL bags.

Woolsey comments that she commends staff for making adjustments during the Emily St. John Mandel Author Talk. She says that it ran very smoothly. Biggins adds that she was supposed to facilitate this event and was sick.

Woolsey also comments that she attended the sci-fi book club and said it was a great experience. She adds that she also attended the Dyers-Ives event and it was lovely.

Boston comments that she attended the Grand Rapids Asian Pacific Festival and Pride Festival. She adds that her wife commented to her that she is very pleased with the new forward-facing displays in the children's section.

Anderson thanked Librarian Nic Coppernoll for helping sign her up for the Summer Reading Challenge. McNaughton adds that we have almost broken last year's sign-up record. Biggins adds that we have almost 6,000 sign ups so far.

#### 5. STAFF & FOUNDATION REPORTS

## A. Library Director's Report

McNaughton comments that the Grand Rapids Children's Museum is doing a feasibility study for the STEAM project. They have met with the City Manager and will be meeting with a smaller committee of City Commissioners in the next couple of weeks. Boston asks about the suspension of some City services until after the election in November and asks if this will also impact the STEAM project. McNaughton answers that he is not sure.

McNaughton introduces Library Analyst Rebecca Near and Platform Administrator Tim Gloege to talk about their work at GRPL. Gloege and Near explain their roles and present the Data & Platform Services Department. Boston thanks them and calls them unsung heroes for supporting every department. She adds that it makes her happy to know that the organization is communicating more wholly and seems less siloed.

McNaughton comments that Facilities Manager Ken Dahlman will be retiring on July 1 after being at the library for 18 years. He adds that David Sturgeon is his replacement and has been working out great so far. July 1 is Ken Dahlman's retirement party and Laplow will send the party information to the board members.

Anderson asks about the Deputy Director position. McNaughton answers that we have two final candidates and the second interviews are scheduled for the second week of July. We will likely have a decision made by the July regular meeting.

## B. Financial Report

Adcock comments that we're wrapping up FY24 this week and FY25 starts next week.

Kopec asks about the \$1.5 million extra and asks if that will go into reserves for next year. Adcock answers that is due to revenues being more than expected and it will go into reserves.

Kopec asks about being over budget for overtime and asks if staff are being overworked. McNaughton answers that staff aren't being overworked.

Boston asks how the parking rate increases have worked out so far. Adcock answers that it seems like it's working well and that he believes all of the changes we've made thus far have been successful. He adds that on Saturday during the Pride Festival, our parking lot wasn't full despite the festival taking place near the library and the rest of the City streets being full of parked cars.

## A. FY25 Michigan Arts and Culture Council Grant Application

Anderson comments that there is a correction to the information within the memo. She explains that the amount requested this year will be \$20,000 instead of \$30,000.

## B. Photography and Video Policy 60-3

Woolsey explains that this policy came from staff and is formalizing a lot of what is already in practice. Director of Marketing and Communications Katie Zychowski explains how it will be implemented. She explains that it is what we have been practicing for a number of years and will largely impact the Communications Department and Communications Assistant Hailey Jansson. She adds that this will allow Jansson to take photographs at events. She concludes that patrons will have the ability to opt out of being photographed and explains some of the procedure.

Anderson asks how the fourth bullet point within the Guidelines for the Public section will be implemented. Zychowski answers that we haven't yet experienced this, but this will be handled on a case-by-case basis and if the request is made, we'd like to honor it.

Boston asks about the second paragraph in the policy regarding using full names. Zychowski explains that personally identifying information like name tags will be removed from photos. She adds that the

Communications Department never identifies or indicates who the person is in a photograph. Boston asks if the wording should be changed to "names" instead of "full names." Zychowoski answers yes.

MOTION: By Commissioner Kopec, supported by Commissioner Boston, that the Board of Library Commissioners of the City of Grand Rapids approve the new Photography and Video Policy 60-3, as amended.

Woolsey comments that she will amend the policy to remove the word "full" in the second paragraph. She also explains that Policy 60-3 is a new policy. She adds that if a staff member is uncomfortable with being photographed, we have Policy 60-1 that can be referenced as well.

GRPL staff attended the following outreach events where we shared library resources and events, offered library card sign-ups, and promoted the library with giveaways:

The Mobile Library began its second year of regular summer routes to neighborhoods, preschools, and housing complexes. We have 9 sites this year and are visiting each one every other week.

The first month of the Summer Reading Challenge has been a great success, with over 6,000 people registered and 400 finishers already. One patron used the feedback from on our website to say:

"Thank you for putting on a great summer reading program. We love the graphics on the new passport-like books - we even picked up a 'read s'more' lawn sign - our kids get so happy seeing it in our front yard. Please continue putting on these programs and using this artist!"

The Ottawa Hills Branch patrons have shown a remarkable level of engagement in the Summer Reading Challenge, with over 600 sign-ups in the first 4 weeks! The branch staff rose to the occasion and provided excellent service to the high volume of people who came into the building.

Our youth and family events have been popular this summer. 275 people attended our first of 3 Summer Reading Celebrations throughout the city, this one in Lincoln Park. 52 patrons, both kids and adults, attended a bike maintenance workshop, led by staff from Switchback Gear Exchange, at the Van Belkum Branch, and many patrons rode their bikes there! After it was a huge success last summer, we brought back our Dungeons & Dragons for Teens program. The first session went great and we look forward to the next one in July. Our outdoor storytimes at Lincoln Park have also been well-attended, and even a surprise thunderstorm couldn't stop one of them (John Ball Area Neighbors graciously opened up their building so storytime could still be held inside)!

The branches have brought the Reader Bug out of hibernation in concordance with the Summer Reading Challenge! The Reader Bug is an annual summer scavenger hunt where kids can claim weekly prizes and enter a monthly book raffle.

The most recent edition of the Small Business Resource Center Newsletter was sent to our digital subscribers and our branches. This edition included an interview with Dan TenHoopen, longtime union member and labor liaison with the Heart of West Michigan United Way, reviews of two popular books on labor history, and book lists.

The Ask a Doctor program has been taking place once per month and has been utilized by several patrons each time it takes place. Feedback from Trinity Health's medical residents has been consistently positive around the level of patron engagement. Based on how well the partnership has been going up to this point for both Trinity Health and GRPL patrons, GRPL and Trinity Health recently agreed to double the frequency of the Ask a Doctor sessions and will now take place twice per month.

## CREATING INSPIRING SPACES & EXPERIENCES

A core team of staff including Operations Manager Andrea Hiler, Librarian Erin Keener, Branch Manager Courtnei Moyses, Graphic Designer Hannah Snow, and Marking & Communications Director Katie Zychowski, have kicked off a multi-year project that will investigate self-service points within the library system. This group is gathering staff feedback about select service points so that we can update our signage to reflect our new visual brand while finding ways to optimize our communication with patrons in the process.

The Communications Department continues to meet with other library systems around the world (including Canada, Denmark, and the USA) to learn more about ways to use strategic design decisions to support the patron experience in library spaces.

The Youth Services Department has a display case where children can display their collections. We always have a waiting list of children hoping to display their collections, and patrons young and old love admiring the display. Currently we have a coin collection; before that was a collection of horse figurines. A parent recently emailed to say:

"Thank you so much for the opportunity for both F. and G. to share their collections and loves. It's been such a joy and led to some fun unexpected connections as well."

## TRANSFORMING OUR CULTURE

The Planning Committee consisting of Library Analyst Rebecca Near, Platform Administrator Tim Gloege, Human Resources Director Natalie Drew, and Marketing & Communications Director Katie Zychowski, in collaboration with the Executive team, continue to refine a large-scale planning system that aligns the city's budget cycle with GRPL's project planning. The committee met with Librarian IIIs to kick off FY26 project planning to help clarify priorities, objective goals, and system deadlines for our upcoming cycle.

## BEING VISIBLE & VALUABLE TO THE COMMUNITY

GRPL and Grand Rapids Children's Museum (GRCM) partnered on a social media video, digital book lists, and physical displays to increase awareness of emotional literacy resources that both institutions offer to celebrate GRCM's most recent exhibit, Emotions at Play. In addition, GRCM donated activity kits to our Madison Square and West Side Branches, featuring literacy resources for parents and caregivers.

## Financial Summary Year End Projection FY24

## **Operating Fund 2710**

#### Revenues

 The library is estimating to have actual revenues received of approximately 111% of budgeted property tax and other revenues in FY24.

## Expenditures

• The library operating fund's actual spending is estimating to exceed 92% of budgeted expenditures for FY24.

Overall, the library operating fund is estimating an FY24 surplus primarily due to actual revenues received exceeding budget projections.

## **Capital Fund 2711**

#### Revenues

• The library capital fund has only one revenue stream for FY24 in the form of interest revenue. It is estimated to actually receive the vast majority of the approximate 58k budget projection.

## **Expenditures**

 Actual spending levels on library building improvements are estimating to exceed 80% of budgeted amounts.

Overall, the library capital fund is estimating an FY24 defect in the range of 600k to 1mil. This will be absorbed by fund balance which was last reported to be at approximately 1.35 mil at the December board meeting. Final numbers for both funds should be available in August and will be reported out at the first subsequent board meeting.

### Proposed Staff Training Date: Wednesday, November 20, 2024

Due to the nature of public libraries, there are very few opportunities for staff to participate in training together within the same space at the same time. We hear from staff each year how beneficial it is to have all-staff inservice days, not only for continued learning, but also for the ability to interact with others across our 8-branch system.

We are proposing closing all of our locations to the public on November 20, 2024 in order to provide additional training for staff. The focus of this inservice will be on the following:

- Project planning: With FY25 in full swing, the organization will holistically receive updates on current projects. The date of this in-service is also poised well for us to refine the approved FY26 projects, reinforce the upcoming FY26's priorities, and allow staff to join project workgroups.
- Safety Training: Similar to Spring 2024 Staff Day, employees will receive relevant training related to patron safety concerns within the library.
- Interaction and Connection: Departments will have individual meetings to connect and strengthen their teams.
- Executive Team Communication and Transparency: The Executive Team
  will be leading this training day, which will allow for staff to interact with
  the team, receive support, and provide feedback.

### Proposed resolution:

RESOLVED that the Board of Library Commissioners of the City of Grand Rapids approve a full day closure for all locations on Wednesday, November 20, 2024, allowing for staff training from 8:00 am to 5:00 pm.


## Physical Items Borrowed by Branch








Digital Usage by Format
